Henry County RTL leadership is gratified to again share an update on current and expanded pro-life billboard messaging. A campaign that began in January of 2025 continues through widespread and generous outpouring of financial support. To date, broad based commitment from partnering donors has brought a total of \$11,081.00; a funding level that allows us to further our billboard messaging through October of 2026 and beyond. Our most recent contract with Huntington Billboards has offered new (six month-May/October) messaging locations northeast of Napoleon at State Route 6 and at Henry County Road 16 southwest of Napoleon. Our existing locations at St Rt 24 and St Rt 6/Northwest State Community College will continue as well through October with this new contract. Billboard costs to date total \$9,866.00. With continued trust and commitment from surrounding area pro-life partners, we humbly anticipate ongoing billboard messaging throughout and beyond calendar year 2026.

**Right to Life Action Coalition of Ohio
Supports Judge David Engler Lawsuit**

CHILLICOTHE, OHIO - The Right to Life Action Coalition of Ohio (RTLACO), the state's largest association of grass-roots pro-life, pro-family organizations is proud to stand by Judge David L. Engler, Trumbull County Court of Common Pleas Domestic Relations/Juvenile Divisions Judge, who filed a lawsuit with the Ohio Supreme Court arguing the 2023 Reproductive Freedom Act violates fundamental parental rights.

Judge Engler believes by excluding parental involvement in critical situations, such as when a teenage girl becomes pregnant, the law improperly compromises the safety of children and he is seeking to uphold the constitutional role of parents in legal and medical decisions.

"I took an oath under God to uphold the Constitution and laws of Ohio. That is what I am doing" stated Judge Engler in a recent communique with RTLACO Board members.

The Statement of Faith of RTLACO articulates the dignity of marriage and value of the family as the basic institution of society, thus the role of the parents to protect and defend the lives of their children is congruent with our mission and values. "We are grateful for the courage, wisdom and determination taken by Judge Engler at this time, putting families first for Ohio" stated Judy Harness, President RTLACO.

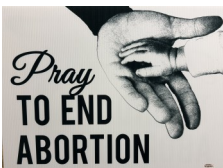

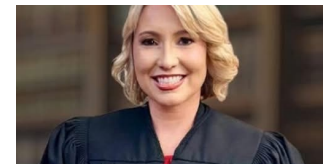

The Right to Life Action Coalition of Ohio (RTLACO) endorses candidates who hold strict, "no-exception" pro-life positions, focusing on protecting life from conception to natural death. Their endorsement process involves a specialized political action panel that evaluates candidates based on their pro-life standards. Note: **Right to Life Action Coalition of Ohio endorsements may not mirror and should not be confused with, endorsements made by Ohio Right to Life.** All candidates seeking endorsements from various pro-life organizations are required to meet varying and specific endorsement eligibility requirements. Pro-life advocate voters are encouraged to seek disclosure information outlining endorsement affiliation of all or any specific candidate(s).

Requirements for RTLAO endorsement include:

- **No-Exception Standard:** The coalition strictly requires candidates to oppose abortion without exceptions for rape or incest.
- **Evaluation Panel:** A dedicated political action panel within the coalition engages directly with candidates to determine their commitment to pro-life legislation.
- **Pro-Life Alignment:** Candidates must exhibit a firm dedication to passing pro-life legislation.
- **Legislative Focus:** They prioritize candidates who support strengthening anti-abortion laws and reversing protections for abortion.
- **Active Involvement:** Candidates with a track record of supporting or taking action in the pro-life movement are preferred.
